Billing Date	1 st of month	02/01/17
Bill Due	20 th of month	02/20/17
Delinquency/Termination Notice (mailed)	26 th of month (\$15 late fee)	02/26/17
Shut Off Notice (on door). Service shut of 8 a.m. (This is actual notice that service is shut off)	Two months from date of bill (\$50 fee)	04/01/17
Disconnection/Lien Notice (letter)	Three months from date of bill	05/01/17
Lien (filed with County Auditor)	Four months from date of bill	06/01/17
Abandoned	After 50 months of nonpayment. New connection fee.	04/01/21
